TRAINING ANNOUNCEMENT**

The State Planning Office, Code Enforcement Officer Training and Certification program will sponsor training workshops for the codes in the building standards specific area: residential building code, commercial building code, residential energy code, commercial energy code, indoor residential ventilation code, and indoor commercial ventilation code. Michael Lessard from Kennebec Valley Community College will be presenting these workshops. Issues covered include, but are not limited to: the statutory requirements of the Maine Uniform Building and Energy Code, code purposes and organization, applicable state laws, review and permitting, report procedure, occupancy approval requirements, inspection and enforcement techniques.

Registration will begin at 8:00 am (or half an hour before scheduled start time). Due to budget restrictions we will not be able to provide food. Please bring coffee and a bag lunch. You will have one (1) hour for lunch if you would like to leave the meeting site.

Code Enforcement Officers and Third-Party Inspectors will earn recertification credits in the codes comprising the building standards specific area (residential building code, commercial building code, residential energy code, indoor residential ventilation code, indoor commercial ventilation code). Individuals seeking certification will find the workshops helpful in preparation for the examinations.

Please note: This is basic training geared toward individuals preparing to sit for exams. The CEO Training and Certification rule states this basic training is mandatory for third-party inspector certification and CEO recertification in the building standards specific area.
