The State Planning Office, Code Enforcement Officer Training and Certification program will sponsor a training workshop on Issues in the Shoreland Zone. The Department of Environmental Protection's Shoreland Zoning Unit will present this workshop. Issues covered include, but are not limited to; erosion control issues, state-wide timber harvesting standards, nonconformance issues, clearing standards and lot coverage, hazard tree determination, water-dependent uses, and legislative updates. Registration will begin at **8:30AM**. The program will begin at **9:00 AM and end at 4:00 PM**. Due to budget restrictions we will not be able to provide food. Please bring coffee and a bag lunch. You will have an hour for lunch if you would like to leave the meeting site for lunch.

Code Enforcement Officers, certified in Shoreland Zoning, will earn six recertification credits in the area of Shoreland Zoning. Individuals seeking certification will find the workshop and materials helpful in preparation for the Shoreland Zoning exam.

Please note: This is basic training geared toward new code enforcement officers as well as those preparing to sit for exams. In the new CEO Training and Certification rule a CEO or LPI can only use 6 credits of basic training toward recertification in any specific certification area.
